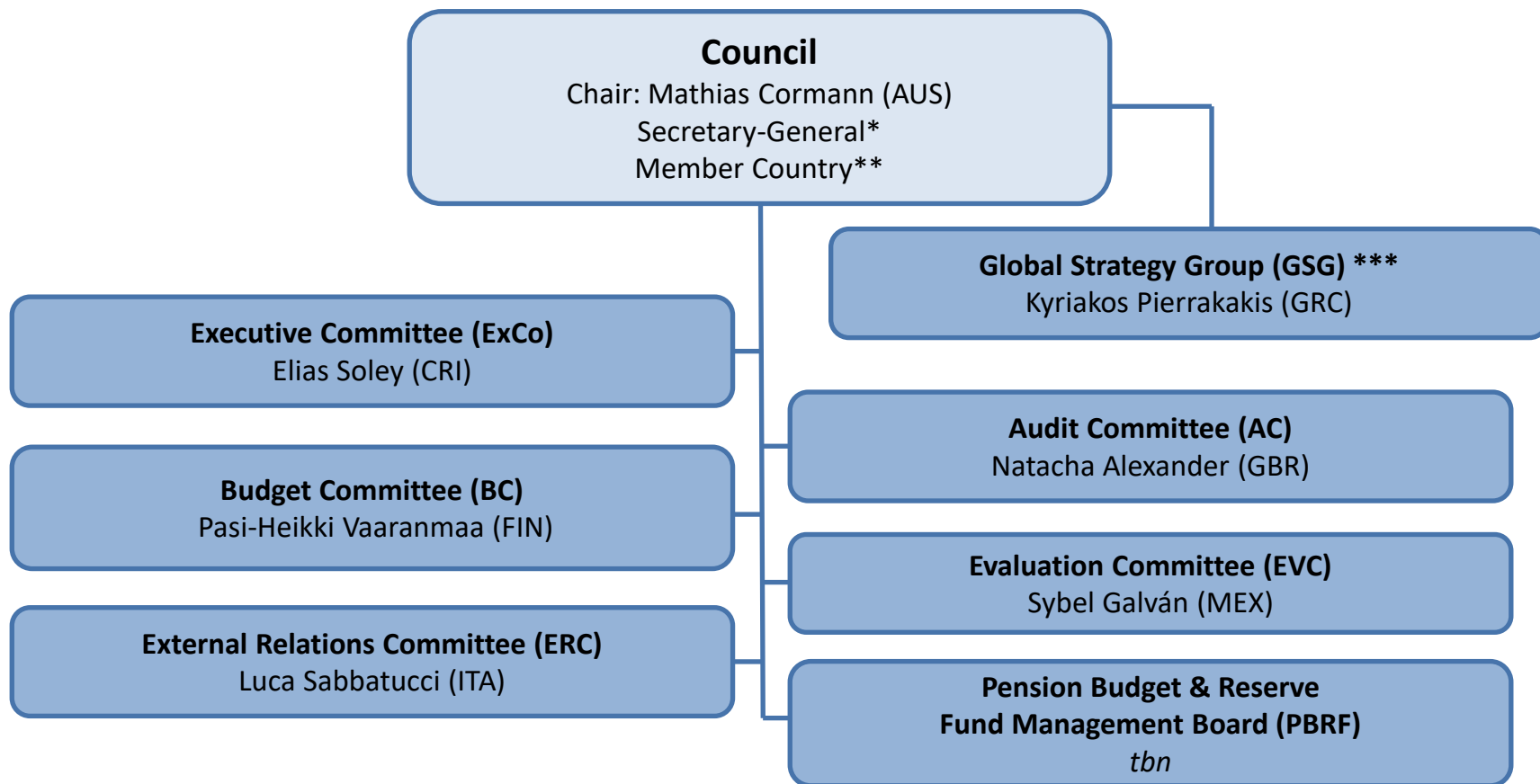

continuation of previous slide – CFA structure



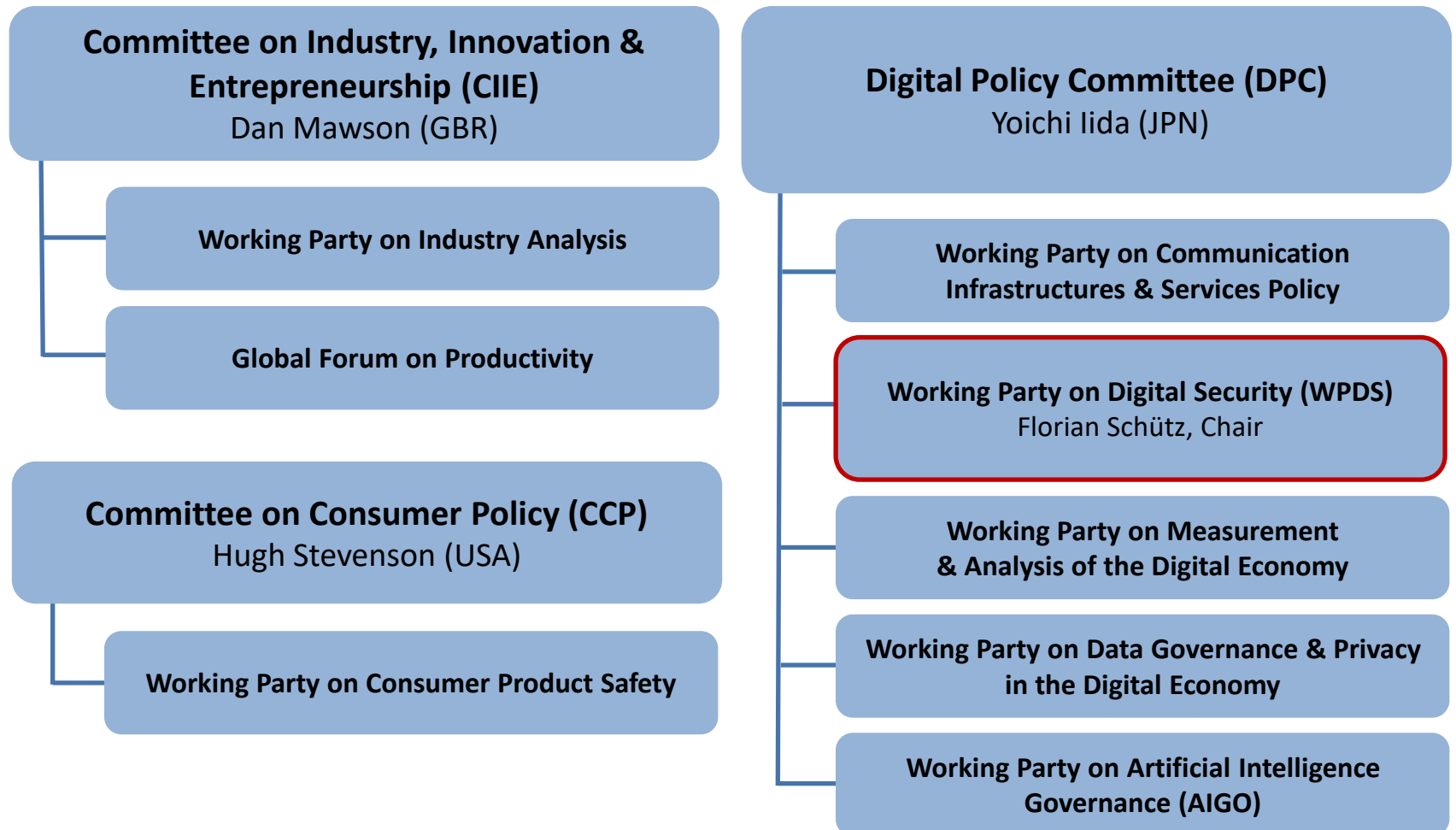
