
Switzerland and Turkmenistan hold political consultations



On 20 May 2020, political consultations were held online between the Ministries of Foreign Affairs of Switzerland and of Turkmenistan. New phase of cooperation with the State Tax Service



The Government of Switzerland, through the State Secretariat for Economic Affairs (SECO), continues its support to the State Tax Service under the Ministry of Economy of Azerbaijan.

The Global Tax Program, which is being implemented by the World Bank and was renewed until June 2022, focuses on the accuracy of taxpayer registry, the risk management framework as well as on the challenges of the informal economy. Acknowledging the current challenges due to COVID-19, the program will also finance short-term just-in-time activities, which will be closely developed with the local authorities.

A screening of the short film "Two Snaps of Post-Modern Society" took place at the Salaam Cinema on 31 January, followed by a debate among the audience and invited experts. The film addresses gender-related issues both in rural and urban Azerbaijan. The Swiss Cooperation Office had supported the short film's production through its small Arts and Culture project.

COVID-19 - Support to Swiss citizens living in Azerbaijan

Due to the worldwide spread of COVID-19 or to personal reasons, some Swiss citizens residing in Azerbaijan and in Turkmenistan had the strong wish to return to their families in Switzerland. Due to the lack of scheduled passenger flights, the Swiss Embassy in Baku has supported them in looking for an alternative mode of transport.

Thanks to the cooperation with other Embassies in Baku and Ashgabat which organized repatriation flights, five Swiss citizens residing in Azerbaijan were able to fly to Rome and Riga, and one Swiss citizen residing in Turkmenistan to Paris.

However, the majority of our fellow citizens remained in Azerbaijan despite the pandemic.

COVID-19 - Visa for Switzerland

Due to the rapid increase of COVID-19 cases in March, on 18.03.2020 the Swiss Federal Council decided to suspend with immediate effect the issuance of all Schengen as well as national visa for Switzerland. Thanks to the improvement of the epidemiological situation in Switzerland, the entry restrictions have been lifted on 08.06.2020 for study and family reunification purposes, on 15.06.2020 for all citizens of Schengen, EU and EFTA states and since 06.07.2020 for all stays of more than 90 days. Such long-term stays must however be authorized by the competent cantonal migration office in advance. Short stays of less than 90 days in Switzerland are still subject to restrictions. Switzerland intends to gradually lift these last entry restrictions in coordination with the other Schengen states.

Please note that travellers from several countries, including Azerbaijan, have to undergo a 10-day quarantine upon arrival in Switzerland. The list of the countries concerned, which is based on epidemiological criteria, will be updated regularly and can be found on the webpage of the Swiss Federal Office of Public Health.

Alberto Hernandez, new Deputy Regional Director of Cooperation and Deputy Head of Mission



Mr Alberto Hernandez was appointed Deputy Regional Director of Cooperation and Deputy Head of Mission in January 2020; in this capacity, he heads the Swiss Cooperation Office in Baku (SCO). Previously, he had worked with the Swiss State Secretariat for Economic Affairs (SECO) and was responsible for the strategic and political positioning of SECO's economic cooperation. In this function, he worked on the elaboration of a new strategy for Swiss International Cooperation 2021-2024, which is currently being discussed in the Swiss Parliament. The thematic focus areas of the new strategy are: creating

decent jobs locally, mitigating climate change and adapting to its effects, reducing the causes of irregular migration and promoting the rule of law. Looking ahead, still greater use will be made of the potential of the private sector and digitalisation. Multilateralism remains an important pillar of Switzerland's international cooperation.

Previously, Alberto Hernandez worked with the Swiss Ministry of Environment and in the private sector. The SCO in Baku implements various projects within the framework of the Swiss Cooperation Strategy South Caucasus. The focus is on the promotion of reliable macroeconomic framework conditions and the promotion of the private sector to create decent income opportunities as well as the implementation of projects in the areas of Women Economic Empowerment, Climate Change and Arts & Culture.

Irina Vogel, Academic Intern, says good-bye to Baku - interview

What were your motivations when applying for the position as an Academic Intern at the Embassy of Switzerland to Azerbaijan and Turkmenistan?

I have always been fascinated by foreign cultures and the complexity of international affairs. My Bachelor studies in International Relations at the University of Geneva as well as my exchange semester in Tokyo confirmed my desire to work in a diverse environment to find solutions to today's global challenges. Gaining an insight into Swiss diplomacy and understanding the functioning of a Swiss representation abroad constitute valuable experiences and show me in what ways the Swiss foreign policy strives to ensure peace and security as well as economic prosperity abroad. Azerbaijan's multiculturalism and its unique geopolitical situation made Baku an attractive choice for my first experience in this field.



Describe a normal day at the Embassy. What are your daily tasks? What have you enjoyed most during your internship?

No two days are the same. Working in a small team, I have had the opportunity to get insights into different diplomatic divisions, which allows for a great variety of tasks but also the challenge to familiarize myself with new topics within a short period of time.

Assisting in the preparation of the visit of the former President of the Swiss Council of States in October 2019 shaped the beginning of a highly diverse internship during which I have had to, inter alia, do research on various topics, draw up reports, attend meetings and conferences, and organize cultural events – some of which had unfortunately to be cancelled shortly before their implementation due to the COVID-19 pandemic.

What I have enjoyed most is learning something new every day and seeing the impact of projects supported by our Swiss Cooperation Office.

Which non-work-related experience stood out the most to you?

In the first few months of my internship, I had the possibility to travel to different parts of the country. My short trip to Nakhchivan with its beautiful landscapes was especially memorable.

I have noticed that Azerbaijanis – just like Swiss – are very helpful. It is not uncommon to be approached by locals who offer their help with one's groceries or to be invited for tea to get introduced to their customs once they realize they are talking to a foreigner. Azerbaijanis are well known for their warmth and hospitality.

I highly recommend everyone interested in learning more about the Swiss foreign policy and in discovering new cultures to apply for an internship at the Federal Department of Foreign Affairs!



The Swiss Parliament (Federal Assembly) is the highest legislative authority at federal level. It is made up of 246 representatives elected by the people. They are from 12 parties and sit in two chambers.

The Federal Assembly is a semi-professional parliament, with most council members also pursuing a profession. The two chambers meet 4 times a year for 3 weeks each and at least once a year together. The sessions are open to the public.

Since 1971 (when they obtained the right to vote) the proportion of women in National Council has risen from 5% to 42%.
