

# Birth of a child in Bangladesh from parents who are not married: entry in the Swiss civil status register

Documents to submit
□ Full Birth Certificate or Extract from the Birth Register The birth certificate must be issued by the competent local authorities of the place of birth. Date of registration, volume, page, and serial number of the register have to be mentioned on the certificate or extract. The document must not be older than six months and issued on official letterhead paper normally used by the competent local authority i.e. Chairman of Union Parishad (Union Council) or Ward Commissioner, or Municipal Committee / Municipal Corporation. Note: For late registrations, additional documents may be requested.
□ original official decree establishing filiation or recognition of paternity
If you (a parent) do not hold Swiss nationality and are not yet registered in the Swiss civil status register, please submit the following:
□ Birth certificate from Bangladesh The birth certificate must be issued by the competent local authorities of the place of birth. Date of registration, volume, page, and serial number of the register have to be mentioned on the certificate or extract. The document must not be older than six months and issued on official letterhead paper normally used by the competent local authority i.e. Chairman of Union Parishad (Union Council) or Ward Commissioner, or Municipal Committee / Municipal Corporation. Note: For late registrations additional documents may be requested.
☐ Unmarried Certificate / Marital Status Certificate from Bangladesh This document must not be older than six months, and must be issued by the competent local authority (Chairman of Union Parishad, or Ward Commissioner, or Municipal Committee, or Municipal Corporation) of the birthplace or that of the latest residence of the applicant in Bangladesh.  → An affidavit alone is not sufficient, and will not be accepted by the Embassy.
□ Nationality Certificate: The document must be issued by the competent local authority
☐ Domicile Certificate: The document must be issued by the competent local authority
□ Copy of passport of all concerned persons
□ <b>Divorce Documents</b> (only if a former marriage was divorced)
□ copy of passport

The original documents are submitted to the civil status authority concerned in Switzerland and must not be older than six months. They will not be returned. Photocopies are not accepted. Additional documents may be required if necessary.

#### **Translation**

Documents that are not in English must be translated.

## Thorough verification

As a rule, foreign civil status documents to be submitted, must undergo a thorough verification of their authenticity by an approved law firm mandated. To this end, a declaration form concerning the voluntary verification of foreign civil status documents needs to be signed during the appointment at the Swiss Embassy.

Additional documents may be required, depending on the conclusions of a lawyer's expert advice or the requirements of the authorities concerned in Switzerland.

The approved law firm mandated may take several months to verify the civil status documents thoroughly.

#### Fees

Entry of the birth in the Swiss civil status register is free of charge.

The thorough verification may cause cost up to BDT 60'000. In case the concerned person agrees, in order to win time, the verification process may be started immediately, once the documents are handed in at the Embassy and an advance payment for the costs of the verification is being paid to the Embassy.
