

Information for Medical / Travel & Health Insurance

All Schengen visa applicants must present a valid medical insurance, which covers the entire trip, including travel to and stay within all the Schengen Member States.

The applicant must provide either the <u>policy</u> from one of the recognized Bangladesh-based companies listed on page 2 of this document or from a certified health insurance company based in Europe (EU or EFTA member state). Submitting a membership card of a health insurance shall not be a sufficient proof. All the insurance policies must fulfill the following points:

Risks

- Coverage of the costs of rescue, repatriation for medical reason, medical emergency and emergency hospitalization in case of accident or sudden illness.
- Minimal coverage of EUR 30'000.

Enforceability of insurance proceeds

- Insurance proceeds must be demandable in any EU and EFTA country (Norway, Iceland, Liechtenstein, Switzerland).
- Court of jurisdiction and prosecution must be, according to the insurance contract, any EU- and EFTA country.
- Insurer guarantees for the payment of the claimed insurance proceeds and therefore disposes of sizeable assets in any EU- and EFTA-country.

The Embassy reserves the right to ask for additional information from the policy holder (e.g. written confirmation by the insurance company regarding full name of policy holder, validity of territory, maximum amount of coverage, date of issue and date of expiry, etc.)

Declaration of guarantee (mainly for visitor visas)

If the Embassy asks for a declaration of guarantee,

- ask the guarantor to procure a travel insurance in the name of the applicant or
- procure your own travel & health insurance according to the above mentioned requirements
