	Confirmation of the Ministry of the Interior regarding the equality of civil and ecclesiastical ceremonies (Βεβαίωση του Υπουργείου Εσωτερικών που ισοβαθμεί τον πολιτικό με το θρησκευτικό γάμο)

For spouses/partners (male or female) who are not Swiss citizens:	
□ Original birth certificate or a certified true copy issued by the Municipality (Πιστοποιητικό γέννησης σε πρωτότυπο ή φωτοαντίγραφο επικυρωμένο από το Δήμο)	
☐ In case of the divorce or dissolution of a registered partnership, please refer to the "Divorce" information sheet on our representation's website	
☐ In case of the death of the spouse of the foreign parent, please refer to the "Death" information sheet on our representation's website	
Certain documents may no longer be required if the person is already registered in the Swiss civil status register.	
The original documents are submitted to the competent civil status authority in Switzerland and $\underline{\text{must}}$ $\underline{\text{not be older than six months}}$. They can be returned on written request only prior to being sent to Switzerland.	
Important: Photocopies and coloured scans legalised by a lawyer or another authority are not accepted. By request of the competent authorities in Switzerland, additional documents may be required, if necessary.	
Legalisation	
All foreign civil status documents must be legalised before being submitted to the Swiss representation. The apostille (Σφραγίδα της Χάγης) is affixed only by the Ministry of Justice and Public Order.	
Translation	
Documents that are not in a Swiss national language or in English must be translated. List of translators: https://www.pio.gov.cy/en/translations/	
Fees	
The registration of the marriage / registration of the partnership of same-sex couples in the Swiss civil status register is free of charge	
Further information	
☐ All original documents must be accompanied by a photocopy.	
☐ The documents must be sent by registered mail or by courier service in order to prevent any loss.	
☐ The registration takes about 2-3 months, depending on the canton.
