



## Leaflet SWISS SCHENGEN VISA MEDICAL TREATMENT

### General application rules:

- Only visa applications with Switzerland as a main travel destination are accepted.  
In case of multiple destinations, the visa must be submitted at the Embassy of the country where the longest stay will be
- All requested documents have to be translated into German, French, Italian or English  
A list of recognized translators can be found at the Embassy website:

- If a requested document cannot be provided, there must be a written explanation instead, clarifying why the document is not available
- The visa fee will not be refunded in case of refusal or withdrawal.
- Communication regarding visa matters are only accepted in written form to [info.cheg@vfsglobal.com](mailto:info.cheg@vfsglobal.com) or by calling +20248837966
- The mandatory "Schengen Consultation", which takes a processing time period of at least 10 working days, can only be started upon receiving a complete application file meeting the requirements
- The Embassy reserves the right to ask for additional documents or a personal interview with the applicant

### How to apply:

Prior to the submission of a visa request, an appointment has to be fixed with our external service provider VFS Center **only online** on the VFS website: <https://visa.vfsglobal.com/egy/en/che/>

### Requirements

Passport	<ul style="list-style-type: none"><li>➤ original and 1 copy of biometric data page plus all non-empty pages</li><li>➤ issued within the last 10 years</li><li>➤ contains at least 2 blank pages</li><li>➤ must be valid for at least 3 months beyond the return from the planned trip</li></ul>
Previous passport	<ul style="list-style-type: none"><li>➤ covering the past 7 years</li><li>➤ copies of biometric data page plus all non-empty pages</li></ul>
1 passport-size personal photo	<ul style="list-style-type: none"><li>➤ with white background</li><li>➤ not older than 6 months</li></ul>
Round-trip Ticket	<ul style="list-style-type: none"><li>➤ only air travel reservation (not confirmed)</li></ul>

Certificate from the local medical doctor / institution	<ul style="list-style-type: none"> <li>➤ containing the medical history of the patient and what kind of medical treatment is needed</li> <li><i>In certain cases, the embassy might request to have the certificate verified by the embassy's medical doctor</i></li> </ul>
Original Certificate of employment (HR-letter)	<ul style="list-style-type: none"> <li>➤ containing the following information: <ul style="list-style-type: none"> <li>• date of recruitment (hiring date)</li> <li>• position</li> <li>• salary level</li> <li>• confirmation of annual leave approval</li> </ul> </li> </ul>
For company owners	<ul style="list-style-type: none"> <li>➤ original and copy of the commercial registry and valid tax card</li> </ul>
For students	<ul style="list-style-type: none"> <li>➤ proof of enrolment in school / university for the current academic year</li> </ul>
International Travel Insurance	<ul style="list-style-type: none"> <li>➤ covering the entire period of intended stay</li> <li>➤ valid for all Schengen countries</li> <li>➤ minimum coverage must be EUR 30'000.00 (includes expenses of repatriation for medical reasons, urgency medical attention, emergency hospital treatment or death during the stay)</li> <li>➤ a printout certificate/policy in English of *AMAN sticker* on the passport</li> </ul>
Bank statement	<ul style="list-style-type: none"> <li>➤ in original</li> <li>➤ covering the past six months</li> <li>➤ only current or saving accounts (Deposit Certificates will <u>not</u> be considered!)</li> <li>➤ closing balance must show sufficient means to cover the expenses of the planned trip</li> </ul>
Visa fees	<ul style="list-style-type: none"> <li>➤ payable in EGP (only exact amount is accepted!)</li> </ul>

#### Requirements from the medical institution in Switzerland

*These requirements should be sent directly to the applicant, to be added to her/his visa application file*

Official invitation letter	<ul style="list-style-type: none"> <li>➤ on official hospital / medical institution paper, stamped and signed containing the following information: <ul style="list-style-type: none"> <li>• full address and contacts of the medical institution</li> <li>• confirmation that it can perform the specific medical treatment and the patient will be accepted accordingly</li> <li>• mentioning the financial arrangements made (approx.. costs, deposits, payment terms)</li> <li>• duration of the planned stay for medical treatment</li> <li>• mentioning eventual accompanying persons</li> </ul> </li> </ul>

#### Additional special requirements

For foreigners living in Egypt	<ul style="list-style-type: none"> <li>➤ must have a residence permit in Egypt valid for at least 3 months beyond the return from the planned trip</li> </ul>
For minors	<ul style="list-style-type: none"> <li>➤ <u>if the minor travels without parents or legal guardian:</u> consent of parental authority or legal guardian provided either through a notarized certificate or by a letter signed at the Embassy or VFS office</li> <li>➤ <u>if the minor travels with one parent or legal guardian:</u> consent of parental authority or legal guardian, who is not travelling with the child, provided either through a notarized certificate or by a letter signed at the Embassy or VFS office</li> <li>➤ passport copy of both parents (biometric data page + page with the signature)</li> <li>➤ Translated Birth Certificate of the minor.</li> </ul>
