

Leaflet SWISS SCHENGEN VISA VISITING FAMILY / FRIENDS

General application rules:

- Only visa applications with Switzerland as a main travel destination are accepted.
 In case of multiple destinations, the visa must be submitted at the Embassy of the country where the <u>longest</u> stay will be
- All requested documents <u>have to be translated</u> into German, French, Italian or English
 A list of recognized translators can be found at the Embassy website:
 https://www.eda.admin.ch/countries/egypt/en/home/dienstleistungen/arzt-anwalt.html
- If a requested document cannot be provided, there must be a written explanation instead, clarifying why the document is not available
- The visa fee will not be refunded in case of refusal or withdrawal.
- Communication regarding visa matters are only accepted in written form to info.cheg@vfsglobal.com or by calling +20248837966
- The mandatory "Schengen Consultation", which takes a processing time period of at least 10 working days, can only be started upon receiving a complete application file meeting the requirements
- · The Embassy reserves the right to ask for additional documents or a personal interview with the applicant
- During the visa processing time, no passport withdrawal is possible.

How to apply:

Prior to the submission of a visa request, an appointment has to be fixed with our external service provider <u>VFS</u> <u>Centre</u> **only online** on the VFS website: https://visa.vfsqlobal.com/egy/en/che/

General requirements

Passport	 original + copies of all non-empty pages issued within the last 10 years contains at least 2 blank pages must be valid for at least 3 months beyond return from the planned trip
Previous passport	 covering the past 7 years copies of biometric data page plus all non-empty pages
1 personal photo	➤ with white background ➤ not older than 6 months
Proof of applicant's marital status in Egypt	 through an extract of the "Kid Aely" (قيد عائلي) family register For singles> ''Kid Fardi'' (قيد فردي) individual register
Round-trip Ticket	> only air travel reservation (not confirmed)
Original Certificate of employment (HR-letter)	 containing the following information: date of recruitment (hiring date) salary level position confirmation of annual leave approval
for company owners for students	original and copy of the commercial registry and valid tax card
	> Proof of enrolment in school / university for the current academic year

International Travel Insurance	 covering the entire period of intended stay valid for all Schengen countries minimum coverage must be EUR 30'000.00 a printout certificate/policy in English of *AMAN sticker* on the passport.
Original bank statement	 covering the past six months only current or saving accounts (Deposit Certificates will not be considered!) closing balance must show sufficient means to cover the expenses of the trip
Visa fees	> payable in EGP (only exact amount is accepted!)

Additional special requirements					
For foreigners living in Egypt	>	must have a residence permit in Egypt valid for at least 3 months beyond the return from the planned trip			
For minors	>	if the minor travels without parents or legal guardian: consent of parental authority or legal guardian provided either through a notarized certificate or by a letter signed at the Embassy or VFS office			
	>	if the minor travels with one parent or legal guardian: consent of parental authority or legal guardian, who is not travelling with the child, provided either through a notarized certificate or by a letter signed at the Embassy or VFS office			

Requirements from the host in Switzerland

These requirements should be sent directly to the applicant, to be added with his/her application

Invitation letter signed & dated

> containing the following information:

> Translated Birth Certificate of the minor.

• full address and contacts of host in Switzerland (phone number, e-mail)

passport copy of both parents (biometric data page + page with the signature)

- if the host is married, both partners living in Switzerland must sign the invitation
- proof of relationship between guest & host
- duration & period of planned visit
- · who bears living & all other costs
- · Assurance that the applicant will return to Egypt before the expiry of the visa

In some cases, a "Declaration of Sponsorship" form is considered necessary <u>after checking the visa application file</u> Please note that a positive "Declaration of Sponsorship" does not guarantee the issuance of a visa.

from Swiss nationals	>	Swiss passport copy (only biometric data page)
from foreigners living in CH	>	Passport copy (biometric data page) plus copy of valid residence permit in CH
from hosts working in an international Organization or diplomatic mission	A	copy of the valid "carte de légitimation" confirmation of employment signed by the international organization or diplomatic mission
