# **Quality and Standards Program in Ghana**

Strengthening the quality and standards compliance capacity in Ghana to facilitate market access for small and medium-sized enterprises in the cashew, oil palm and cocoa value chains

Exporters from Ghana, in particular small and medium-sized enterprises (SMEs), struggle to meet conformity standards for market entry. The Global Quality and Standards Program (GQSP) in Ghana – implemented by the United Nations Industrial Development Organization (UNIDO) – addresses these challenges by ensuring that the Ghanaian quality infrastructure system and conformity assessment services are enhanced.

## Rationale

Despite the opportunities induced by trade liberalisation and the efforts made by developing countries to strengthen integration into the world trade system, Ghana has been rather slow in accessing global markets. One major reason is that exporters from Ghana, in particular SMEs, face substantial challenges to meet and prove conformity with standards, technical regulations and market requirements.

Since the late 1990s international trade and its negotiations have significantly shifted from tariffs to non-tariff barriers to trade (NTBs), which are very diverse and difficult to quantify. NTBs are not new to trade. However, globalised trade has seen a proliferation of these as a response to increased demand for safety and quality of products, as well as increasing public concern for social, environmental and sustainability issues. This reduction of tariff levels coinciding with an increase in NTBs has proven to be a challenge for Ghanaian SMEs to access global markets.

# Objectives and activities

The objective of GQSP is to strengthen the quality and standards compliance capacity to facilitate market access in Ghana for SMEs in the cashew, oil palm and cocoa value chains. In order to achieve the objective, the program will pursue three outcomes, thus responding to the main compliance challenges identified for the competitiveness of these value chains. These three outcomes are namely:

 Technical competence and sustainability of the National Quality Infrastructure System is enhanced: Strengthening the technical competences of the Quality Infrastructure (QI) at the institutional level by standardization (e.g. management of relevant standards in the selected value chains) and metrology (e.g. delivery of viscometer, ensuring traceability of measurement, etc.). The aim is also to strengthen the technical competence of the Country/region

conformity assessment service providers and institutions via testing, inspections and certifications.

- 2. SME compliance with international standards and technical regulations is enhanced: Improving of compliance capacity through specialised training, capacity building and preparation for certification, strengthening of cluster networks and quality consortia as well as relevant support institutions. In order to support SMEs along the value chain, a pilot application of block-chain technology will be launched to improve traceability along the cocoa value chain.
- 3. Awareness for quality is enhanced: Promoting a culture for quality by ensuring support in the oil palm and cashew industry through the delivery of awareness and training programs by up-scaling knowledge dissemination on best practices and guidelines, and providing advice for informed policy decisions on standards compliance and support for policy development. The creation of a quality infrastructure map to serve as a directory of laboratories is also planned.

The Embassy of Switzerland in Ghana takes part in the GQSP Steering Committee biannual meetings jointly organised by UNIDO, SECO and the Government of Ghana, involving all program partners (Ministry of Trade and Industry, Ghana Standards Authority, Food and Drugs Authority, Ghana Cocoa Board Quality Control Company, Ghana Export Promotion Authority) to exchange and discuss the results and future directions of the program.

### Achievements

GQSP has made significant progress despite the disruptions of the COVID-19 pandemic. The program carried out a study to explore the feasibility of Ghana's cocoa value chain adopting block chain. To help Ghana's fight against the pandemic, GQSP supported the Ghana Standards Authority to adopt and develop forty relevant standards for the quality assessment of facemasks and shields, sanitizers, ventilators, PPE as well as a series of test methods. Furthermore, nineteen different standards and interpretation documents were developed, adopted and then promoted throughout the oil palm, cashew and cocoa value chains. Besides the organisation of RSPO (Roundtable on Sustainable Palm Oil) and HACCP (Hazard Analysis and Critical Control Points) certification trainings for SMEs in the oil palm and cashew value chains respectively, and the RSPO certification of a smallholder oil palm farmer group, GQSP in collaboration with the Ministry of Trade and Industry conducted trainings for national experts of Business Resource Centres and staff of 1D1F companies. These have helped to align the program with the government's industrialization agenda and also companies to comply with relevant standards. Seven testing laboratories are being supported to upgrade technical capacities for various accreditations.

GQSP also piloted a new tool – the Qualtrics – which helps to assess the quality awareness in the different value chains. The assessments conducted have revealed that some work remains to be done to entrench the awareness of quality along the Ghanaian cocoa, cashew and oil palm value chains.
