<b>Valid national passport :</b> <ul style="list-style-type: none"> <li>○ Issued within the last 10 years and with at least 3 months validity after the scheduled return, with at least two blank pages. Handwritten passports and passports with observations regarding the front page (bio data) cannot be accepted.</li> </ul>	<input type="checkbox"/>
<b>1 passport size picture:</b> <ul style="list-style-type: none"> <li>○ White background, not older than 6 months (size 35 – 40 mm in width, not copied or scanned picture).</li> <li>○ Picture to be pasted on the application form, stapled or pinned pictures cannot be accepted. <b>Visa application form :</b> <ul style="list-style-type: none"> <li>○ Completed and signed by the applicant, if applicable, authorization of third person.</li> </ul>	<input type="checkbox"/>
<b>Introduction letter from the employer :</b> <ul style="list-style-type: none"> <li>○ Letter (original document), needs to be on a business letterhead from the employer/company.</li> <li>○ Letter needs to be signed and stamped by HR or directorate, mentioning person, position, duration of service, dates and purpose of the trip, plus stating, if expenses are covered by employer/company.</li> </ul>	<input type="checkbox"/>
<b>Invitation letter from the business partner in Switzerland :</b> <ul style="list-style-type: none"> <li>○ Including full details of the inviter: full name, address, Email-ID and telephone number.</li> <li>○ Original or copy, signed &amp; stamped, mentioning invitee details, dates and purpose of the trip, plus detailed schedule of the business meetings or training (day to day schedule).</li> </ul>	<input type="checkbox"/>
<b>Travel Insurance :</b> <ul style="list-style-type: none"> <li>○ Please refer to the list of approved Indian travel insurances: <a href="https://www.eda.admin.ch/dam/countries/countries-content/india/en/visa/SchengetList-Travel_Insurance_Companies-EN.pdf">https://www.eda.admin.ch/dam/countries/countries-content/india/en/visa/SchengetList-Travel_Insurance_Companies-EN.pdf</a></li> <li>○ Minimum coverage of 30,000 Euro/ 50,000 CHF per person.</li> <li>○ Coverage of all expenses which might arise in connection with repatriation for medical reasons, urgent medical attention and/or emergency hospital treatment.</li> <li>○ The insurance has to cover the entire stay in the Schengen territory.</li> <li>○ Applicants who wish to apply for a six months or a one year multiple entry visa are not obliged to provide a 180 (365) day coverage. It is sufficient to submit an insurance policy covering the first journey.</li> </ul>	<input type="checkbox"/>
<b>Flight reservation :</b> <ul style="list-style-type: none"> <li>○ With names of all travelers.</li> </ul>	<input type="checkbox"/>
<b>Proof of financial status :</b> <p>All documents have to be originals, in A4 format, with stamp and signature of Bank.</p> <ul style="list-style-type: none"> <li>○ <b>If employed :</b> <ul style="list-style-type: none"> <li>● Proof of employment: employment contract, last 3 months salary slips</li> <li>● Last 3 months personal bank account statements in which the salary is credited</li> <li>● Personal ITR (<b>only ITR-V, Indian Income Tax Return Verification Form or Acknowledgement is accepted</b>) for the last 2 assessment years.</li> </ul> </li> <li>○ <b>If self-employed and/or company owner:</b> <ul style="list-style-type: none"> <li>● Business registration certificate / <b>GST Registration with annex A &amp; B</b> / Partnership Deed / Proof of proprietorship, or other proof of ownership.</li> <li>● Last 3 months personal bank statements</li> <li>● Personal ITR (<b>only ITR-V, Indian Income Tax Return Verification Form or Acknowledgement is accepted</b>) for the last 2 assessment years.</li> </ul> </li> <li>○ <b>If retired :</b> <ul style="list-style-type: none"> <li>● Personal pension bank statement for the last 3 months.</li> <li>● Proof of regular income generated by ownership of property or business.</li> </ul> </li> </ul>	<input type="checkbox"/>
<ul style="list-style-type: none"> <li>○ <b>Visa fee :</b> Adults: <b>EUR 90.00</b></li> </ul>	<input type="checkbox"/>

Please note:

- The required documents have to be submitted with the visa application (no fax or e-mail to Embassy accepted).
- Only the documents mentioned on the checklist are accepted.
- The Embassy of Switzerland reserves the right to ask for additional documents and/or for a personal interview.

Accompanying spouses and children of business travelers are kindly requested to submit the documents as per the respective checklist (e.g. tourist or visitor).

**Information for Certificate of Identity (CoI) and Identity Certificate (IC) holders:**

Additionally required documents are:

- valid Residence Certificate (RC)
- valid Return Visa
