

Following a selection procedure organised by the Ministry of Development, Public Works and Administration, 11 localities will benefit from Swiss financing to improve their energetic performance: municipalities of Brasov, Baia Mare, Alba Iulia, Targoviste, Piatra Neamt, Satu Mare, Sibiu, Campia, Oltenita, Barlad and the city of Buhusi.

This Programme also focuses on the creation of the Romanian European Energy Award (EEA), under the responsibility of the Ministry of Investments and European Funds, in partnership with the Association of Regional Development Agencies (ROREG). The European Energy Award supports local governments in establishing interdisciplinary planning approaches and implementing effective energy and climate policy measures through the rational use of energy and increased use of renewable energies.
