


# SWISS – ROMANIAN Cooperation Programme



## SOCIAL INCLUSION PROGRAMME

CHF 20 million



**Overall objective:** reduce the socioeconomic disparities in Romania, and foster an inclusive as well as a cohesive society by providing an equal access to integrated community services for vulnerable communities, especially Roma, and by implementing measures that promote non-discrimination.



**Implementation period:** 2025 - 2029



The first component focuses on vulnerable communities, including disadvantaged Roma, living in marginalized urban areas, and their access to public integrated community services, combining social/health/educational assistance. The urban localities are to be selected through a call for applications published by the Ministry of Labor, Family, Youth and Social Solidarity. This initiative is supported by the Council of Europe, partner in this component.

Complementary to the first component, the second initiative aims at implementing measures promoting non-discrimination at national and local level, including through culture and history of Roma minority. The consortium composed by Roma Education Fund Romania, in partnership with ERIAC Romania and the association Amphiteatrom acts as the Programme Component Operator.
