	Original unabridged Marriage Certificate* or unabridged Civil Union Certificate* (containing the full information, including the civil status of both partners before marriage/partnership), issued by the Department of Home Affairs (DHA) and legalized with an Apostille (see page 2)
	Original unabridged Birth Certificate* of South African spouse/partner, issued by the Department
	of Home Affairs (DHA) and legalized with an Apostille (see page 2)
	Original Certificate of residence* from the South African spouse/partner, affidavit mentioning the
	detailed residence address of (at least) the last six months as well as the period (since until), issued by a Commissioner of Oaths
	Photocopy of Swiss Passport or ID Card of Swiss spouse/partner
	Photocopy of Passport or ID card of the South African spouse/partner indicating the surname after the marriage/partnership
	If the Swiss spouse is a dual citizen: photocopy of South African Passport or ID card indicating the surname after the marriage/partnership
	Marriage questionnaire, completed and signed by both spouses/partners

	Original certified copy of the Final Order of Divorce/dissolution of partnership*, issued by the
	competent High Court and legalized with an Apostille (see page 2)

If the surname after marriage of the Swiss citizen is neither clearly indicated on the marriage/civil union certificate nor on any other official document, a **Declaration of Name** can be requested by the authorities of Switzerland. This declaration of name has to be completed and signed in person by both spouses at the competent Swiss representation.

The original certificates are submitted to the competent civil status authority in Switzerland and will not be returned (photocopies or certified copies with an Apostille issued by a Public Notary are not accepted). Additional documents may be required by the Swiss civil status authority.

Only original certificates with seal and signature of the competent Officer of the Department of Home Affairs (DHA) or the Registrar of the High Court in charge can be accepted.

All documents marked with a * must not be older than six months (date of issue) at the time of their submission to the Regional Consular Centre (RCC) or the Consulate General.

Translation

Documents that are not in English must be translated into a Swiss national language (German, French, Italian or Romansch).

Apostille

The process to obtain an **Apostille** on the certificates issued by the Department of Home Affairs (DHA) is described on the website of the Department of International Relations and Cooperation (DIRCO).

Fees

Entry of the marriage/partnership in the Swiss civil status register is free of charge, however in certain cases fees can occur. If this is the case, you will be informed accordingly.

Processing time

Once the complete documentation has been received by the competent Swiss representation, experience has shown, that this process can take several weeks or months.

Further information

If the documents are sent by mail: Please include a cover letter mentioning your personal and contact details. It is however strongly recommended to use a private courier company.

Only once the marriage/partnership has been registered in Switzerland, a new Swiss passport can be issued in case of surname change after the marriage.

Please contact the Regional Consular Centre Southern Africa (RCC) at the Embassy of Switzerland in Pretoria or the Consulate General of Switzerland in Cape Town if a citizen of a different country is concerned or the marriage took place outside of South Africa.
