<b>Visa application:</b> <ul style="list-style-type: none"> <li>Duly completed (German, French, Italian or English) with a blue or black pen</li> <li>Personally signed in the foreseen box</li> <li>If your fingerprints are already stored in the Schengen System an authorized person in possession of a dated and signed letter can submit your visa application</li> </ul>	<input type="checkbox"/>
<b>Valid Passport:</b> <ul style="list-style-type: none"> <li>Issued within the last 10 years</li> <li>Minimum 2 empty pages</li> <li>Valid at least 3 months after leaving the Schengen Area</li> <li>Copies of passport (pages 2-3) and previous visas with entry/exit stamps</li> </ul> <b>Non-Turkish nationals:</b> <ul style="list-style-type: none"> <li>Proof of residence in Turkey, valid three months beyond the intended date of departure from the territory of the Member States</li> </ul>	<input type="checkbox"/>
<b>1 recent biometric passport picture (not older than 6 months)</b>	<input type="checkbox"/>
<b>Statement of Family register (entire Family) «tam tekmil vukuatlı nüfus kayıt örneği»</b>	<input type="checkbox"/>
<b>Current letter of the receiving medical institution</b> in German, French or Italian: <ul style="list-style-type: none"> <li>Letter must be signed by the doctor</li> <li>It must be evident that the specific medical treatment can be carried out and the patient will be accepted accordingly</li> <li>Information on the cost of the treatment</li> <li>Confirmation of the illness and an appointment confirmation</li> <li>Medical report</li> <li>Documents proving that medical, hospital and hotel expenses are covered by the applicant, if relevant, proof of full or partial prepayment</li> </ul>	<input type="checkbox"/>
<b>Accident and Health Insurance (Original and copy):</b> <ul style="list-style-type: none"> <li>Signed and stamped</li> <li>Minimum coverage of EUR 30.000.- / USD 50.000.- / CHF 50.000.-</li> <li>Valid for all Schengen countries and the total duration of the intended stay</li> <li>The insurance must cover the costs of any repatriation for medical reasons, emergency medical care and/or emergency hospitalization</li> </ul>	<input type="checkbox"/>
<b>Flight reservation (Roundtrip)</b> <ul style="list-style-type: none"> <li>If the Trip is by Bus: Reservation of Bus ticket</li> <li>If the Trip is by car: Driver license and «green card / Triptik» from Turkish Touring Club</li> </ul>	<input type="checkbox"/>
<b>Evidence of financial resources:</b> <ul style="list-style-type: none"> <li>Current Bank statement of last 3 months, proving the source of regular income, with stamp and signature of the Bank</li> <li>Salary proof of last 3 months</li> </ul>	<input type="checkbox"/>

<b>Lawyer:</b> Admission Bar association (Baro kaydı)	<input type="checkbox"/>
<b>Farmer / Agriculturist:</b> Proof of certificate issued by Chamber of Agriculture	<input type="checkbox"/>
<b>Retirees:</b> Proof of retirement with bank statement which confirms the retirement salary	<input type="checkbox"/>

<p><b>Minors, travelling alone:</b></p> <ul style="list-style-type: none"> <li>• Current notarial declaration of consent of the of legal representative (muafakatname) original and copy, the original will be given back</li> <li>• Legal representative: Divorce decree with child custody or death certificate</li> </ul> <p><b>Minors, travelling with 1 parent or accompanying person:</b></p> <ul style="list-style-type: none"> <li>• Current notarial declaration of consent of the of legal representative (muafakatname) original and copy, the original will be given back</li> <li>• Legal representative: Divorce decree with child custody or death certificate</li> <li>• Accompanying person, valid passport and valid Schengen visa</li> </ul>	<input type="checkbox"/>
<p><b>Visa fee:</b></p> <p><b>Payment: Only in Turkish currency and cash:</b></p> <ul style="list-style-type: none"> <li>• Adult: 90.- €</li> <li>• Child, 6 -12 years: 45.- €</li> <li>• Child, 0 - 6 years: 0.- €</li> <li>• Visa fees for spouses of Swiss or EU/Schengen citizen are free of charge</li> </ul>	<input type="checkbox"/>
