Notification to the Signatory and Acceding States to the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES), concluded in Washington on 3 March 1973

I. Reservation entered by the French Republic

On 31 October 2000, the French Republic entered, pursuant to Article XVI, paragraph 2 of the CITES, a reservation with respect to the listing of *Mustela altaica, Mustela kathiah* and *Mustela sibirica* in Appendix III of the Convention.

II. Reservation entered by the Kingdom of Denmark

On 8 November 2000, the Kingdom of Denmark entered, pursuant to Article XVI, paragraph 2 of the CITES, a reservation with respect to the listing of the following species in Appendix III of the Convention:

Mustela altaica Mustela erminea ferghanae Mustela kathiah Mustela sibirica Vulpes vulpes griffithi Vulpes vulpes montana Vulpes vulpes pusilla

III. Reservation entered by the Republic of Finland

On 15 November 2000, the Republic of Finland entered, pursuant to Article XVI, paragraph 2 of the CITES, a reservation with respect to the listing of the following species in Appendix III of the Convention:

Mustela altaica Mustela erminea ferghanae Mustela kathiah Mustela sibirica Vulpes vulpes griffithi Vulpes vulpes montana Vulpes vulpes pusilla

IV. Reservation entered by the Kingdom of Belgium

On 19 January 2001, the Kingdom of Belgium entered, pursuant to Article XVI, paragraph 2 of the CITES, a reservation with respect to the listing of the following species in Appendix III of the Convention:

Mustela altaica Mustela erminea ferghanae Mustela kathiah Mustela sibirica Vulpes vulpes griffithi Vulpes vulpes montana Vulpes vulpes pusilla

V. Reservation entered by the Grand Duchy of Luxembourg

On 26 January 2001, the Grand Duchy of Luxembourg entered, pursuant to Article XVI, paragraph 2 of the CITES, a reservation with respect to the listing of *Mustela altaica*, *Mustela kathiah* and *Mustela sibirica* in Appendix III of the Convention.

VI. Acceptance of the amendment of Gaborone by the Principality of Liechtenstein

On 21 December 2000, the Principality of Liechtenstein deposited with the Swiss Government an instrument of acceptance of the amendment of article XXI of the CITES, adopted at Gaborone on 30 April 1983.

VII. Acceptance of the amendment of Gaborone by the Republic of Paraguay

On 22 February 2001, the Republic of Paraguay deposited with the Swiss Government an instrument of acceptance of the amendment of article XXI of the CITES, adopted at Gaborone on 30 April 1983.

The amendment of Gaborone has not entered into force yet.

The present notification is addressed to the Governments of the Signatory and Acceding States in conformity with article XXV, paragraph 2, of the CITES.
