## Bringing Justice to Khyber Pakhtunkhwa

Malakand Division of Khyber Pakhtunkhwa Province suffered three years of extremist activities, which adversely affected its already weak legal and security system. With its 'Strengthening Rule of Law Programme', the Swiss Agency for Development and Cooperation (SDC) supports the Government of Pakistan (GoP) to establish an efficient and equally accessible security and justice system. The aim of this programme is to stabilise the region by strengthening legal institutions in Khyber Pakhtunkhwa. The programme is implemented by the United Nations Development Programme (UNDP).

The SRLM programme further aims to increase access to an improved justice system, ensure that alternative dispute resolution mechanisms provide fair and effective justice in accordance with the Constitution of Pakistan, improve the capacities of courts and lawyers, and introduce the concept of community policing and oversight to improve the performance of the police in the region.

The first phase of the programme focused on both the demand and supply side, specifically the police, the judicial sector, legal aid and alternative dispute resolution as well as traditional legal mechanisms, such as the Jirgas (group of tribal elders). The programme has enjoyed significant success and by improving court performance and strengthening the legal aid system, it has increased access of the population, particularly women and the most vulnerable in Malakand Division, to an improved justice system. The first forensic science laboratory was established in Swat. Ongoing training sessions and advocacy events have also been part of the

project as well as the provision of institutional support to the police.

## Empowering Female Practitioners

One of the ways the programme is improving access to the legal system is by increasing the number of female practitioners in Khyber Pakhtunkhwa. The programme provides scholarships to female students, connects female graduates to bar associations and strengthens the capacity of female lawyers. It has made the environment for female lawyers more conducive by constructing bar rooms and waiting areas for female litigants. The legal aid clinics held under the programme receive more women than men, and they bring cases related to inheritance, family disputes, and child maintenance.

In 2015, the Pakistan Institute of Legislative Development and Transparency (PILDAT), conducted a survey called 'Public Opinion on Quality of Governance in Pakistan'. It established that the approval rating of law and order in Khyber Pakhtunkhwa improved from 45% to 72% in 2015. Through continuation of this intervention, the SDC aims that the communities, particularly women and the poor, to have equitable access to the fair legal assistance. This is due to be achieved by increasing the effectiveness and the efficiency of the formal legal system and making legal aid sustainable by institutionalising it in the bar associations.
