

## List of National Authorities against Corruption

En octobre 2014, le Conseil Fédéral a pris connaissance du rapport d'activité 2011-2013 du Groupe de travail interdépartemental pour la lutte contre la corruption (GTID). Ce rapport fait état des efforts entrepris en 2011-2013 pour appliquer les recommandations formulées par le Comité du GTID en 2011 et énumère les mesures prises en matière de sensibilisation, les travaux législatifs en cours et les tendances internationales dans le domaine de la lutte contre la corruption. Il émet en outre dix recommandations en vue de renforcer le dispositif anti-corruption de la Suisse. La présente liste met en oeuvre la quatrième recommandation: "le comité de pilotage du GTID recommande au DFAE (DPES) d'établir, une liste des services de lutte contre la corruption existant dans les différents pays et de la mettre notamment à la disposition des entreprises privées."
