Rapporto del Consiglio federale destinato alle Commissioni della politica estera

20 giugno 2025

Conflitti armati, tensioni geopolitiche e impatto della nuova amministrazione statunitense

Lo scopo di questo rapporto è fornire una retrospettiva della 79^a sessione dell'Assemblea generale delle Nazioni Unite (AG-ONU, settembre 2024–settembre 2025), presieduta da Philemon Yang, ex primo ministro del Camerun. Nel suo primo discorso aveva annunciato di voler fare dei temi del finanziamento dello sviluppo, dell'eliminazione del lavoro minorile e della pace e della sicurezza in Africa, le priorità del suo mandato.

La presidente della Confederazione Viola Amherd e il consigliere federale Ignazio Cassis hanno rappresentato la Svizzera alla sessione di apertura nel settembre del 2024. La presidente ha partecipato anche al Summit del futuro, dove ha ribadito il sostegno della Svizzera alla riforma del multilateralismo tesa a renderlo più efficace e in grado di affrontare le sfide odiere. Nel quadro del summit è stato adottato per consenso il Patto per il futuro.

I conflitti armati a Gaza, in Myanmar, nella Repubblica Democratica del Congo, in Sudan e in Ucraina sono stati al centro dei lavori della sessione dell'AG-ONU. Le discussioni si sono concentrate sul diritto internazionale, in particolare sul diritto internazionale umanitario (DIU). In un contesto segnato da forti tensioni geopolitiche, l'AG-ONU è stata caratterizzata da una forte polarizzazione e da diverse votazioni su risoluzioni relative alla guerra in Ucraina e al conflitto a Gaza.

In parallelo sono iniziati o si sono conclusi con successo negoziati su questioni importanti per le Nazioni Unite, come quelli sulla governance globale dell'intelligenza artificiale avviati nel contesto del Patto digitale globale. Inoltre, con la facilitazione della Svizzera è stata adottata una risoluzione sulla riforma del sistema di sviluppo delle Nazioni Unite. Altri punti salienti di questa sessione sono stati l'adozione per consenso, nel marzo del 2025, della dichiarazione politica «Beijing +30», che segna il 30° anniversario della Conferenza mondiale sulle donne, e la quarta Conferenza internazionale sul finanziamento dello sviluppo (giugno–luglio 2025, Siviglia).

L'insediamento della nuova amministrazione statunitense nel gennaio del 2025 ha avuto un forte impatto sui lavori di questa sessione. La crisi di liquidità dell'ONU, dovuta ai ritardi nei pagamenti delle quote di diversi Stati membri, è stata aggravata dalla sospensione o dalla cancellazione di molti contributi versati in passato dagli Stati Uniti. Ciò ha avuto ricadute negative anche sulla Ginevra internazionale. In questo contesto, nel marzo del 2025 il segretario generale António Guterres ha annunciato il lancio dell'iniziativa UN80 consistente in un'intensificazione delle riforme avviate durante il suo primo mandato (cfr. pag. 4). Il cambiamento di paradigma degli Stati Uniti ha inciso anche sulla negoziazione delle risoluzioni dell'AG-ONU, con gli Stati Uniti che ora si oppongono all'uso di formulazioni concordate («agreed language») in ambiti quali il clima, l'ambiente, il genere e l'Agenda 2030.

La Nostra Agenda Comune

Nel rapporto «La Nostra Agenda Comune» del settembre 2021 il segretario generale ha esposto la sua visione per il futuro della cooperazione internazionale, sostenendo un multilateralismo inclusivo, interconnesso ed efficace. Il Patto per il futuro, adottato per consenso al Summit del futuro nel settembre del 2024, riafferma l'impegno degli Stati nei confronti del diritto internazionale e dei tre pilastri dell'ONU: sviluppo sostenibile, pace e sicurezza, diritti umani. Infine, sono iniziati i preparativi per l'ultimo dei tre vertici previsti nel rapporto «La Nostra Agenda Comune», ossia il Vertice mondiale sullo sviluppo sociale che si terrà a Doha nel novembre del 2025.

Diritto internazionale

Le regole del diritto internazionale sono sempre più disattese: numerose violazioni si osservano in particolare nel contesto delle guerre in Ucraina, Medio Oriente, Sudan e Myanmar. Nel febbraio del 2025 l'AG-ONU ha adottato due risoluzioni che chiedono la fine della guerra in Ucraina, iniziata nel febbraio del 2022. Nel settembre 2024 ha inoltre adottato una risoluzione che chiede l'attuazione del parere consultivo della Corte internazionale di giustizia (CIG) che dichiara illegale l'occupazione da parte di Israele del territorio palestinese. Inoltre, nel dicembre 2024 l'AG-ONU ha chiesto alla CIG un nuovo parere consultivo sugli obblighi di Israele riguardo alla presenza e alle attività delle Nazioni Unite e di Stati terzi. La delegazione svizzera ha contribuito a entrambe le procedure di parere consultivo.

Il 75° anniversario delle Convenzioni di Ginevra, celebrato nel 2024, avrebbe potuto essere l'occasione per gli Stati di ribadire il loro impegno in favore del rispetto del DIU. Tuttavia, nonostante l'importanza del DIU, l'attuale contesto globale è caratterizzato da sue sistematiche violazioni. Molti Stati hanno espresso la volontà di riaffermare il loro impegno nei confronti del DIU. Ciononostante, viste le persistenti sensibilità legate alla situazione in Medio Oriente, la Svizzera, in qualità di Stato depositario, ha ritenuto che non vi fossero le condizioni per lo svolgimento – a marzo del 2025 – della conferenza delle Alte Parti contraenti delle Convenzioni di Ginevra, su mandato dell'AG-ONU. A giugno del 2025 si è comunque tenuta a New York una conferenza delle Nazioni Unite sul Medio Oriente per discutere della soluzione dei due Stati.

Nell'ottobre del 2024 l'AG-ONU ha eletto la Svizzera al Consiglio dei diritti umani delle Nazioni Unite (CDU) per il periodo 2025–2027. Con la nomina per acclamazione dell'ambasciatore Jürg Lauber alla presidenza per l'anno 2025, i lavori di questo organo centrale dell'ONU sono dunque passati sotto la guida del rappresentante svizzero.

L'adozione da parte dell'AG-ONU della Convenzione delle Nazioni Unite sulla cybercriminalità alla fine del 2024 rappresenta un traguardo importante verso il rafforzamento della cooperazione internazionale in questo ambito, nonché un contributo significativo agli sforzi tesi a chiarire e promuovere l'applicabilità del diritto internazionale nel cyberspazio. Per la Svizzera è fondamentale che il diritto internazionale, e in particolare i diritti umani, rimangano la pietra miliare della regolamentazione internazionale in materia di digitalizzazione.

Sistema finanziario internazionale

I Paesi emergenti e in via di sviluppo fanno valere con sempre più insistenza davanti all'AG-ONU le loro richieste di riorientamento dell'architettura finanziaria internazionale, che comprende le agenzie specializzate dell'ONU, l'FMI, la Banca Mondiale, l'OCSE e le banche di sviluppo regionali. In questo contesto si è svolta la quarta Conferenza internazionale sul finanziamento dello sviluppo (a giugno–luglio del 2025 a Siviglia). La conferenza dovrebbe concludersi con l'adozione di una dichiarazione non vincolante volta ad armonizzare meglio i flussi finanziari, gli Obiettivi di sviluppo sostenibile e i finanziamenti innovativi, che includono il settore privato. Infine, hanno preso il via i negoziati per l'elaborazione di una convenzione quadro delle Nazioni Unite sulla cooperazione internazionale in materia fiscale.

Riforme dell'ONU

Negli ultimi anni sono state attuate diverse riforme nei seguenti settori: 1) pace e sicurezza, 2) sviluppo e 3) gestione. Con il ritiro o la sospensione dei contributi finanziari da parte degli

Stati Uniti, l'ONU si trova più che mai ad affrontare una crisi che mette in discussione la sua capacità di agire (cfr. pag. 2). L'organizzazione prevede una riduzione dell'11,3 per cento del suo budget globale entro il 2025. Di fronte a questa situazione senza precedenti, nel marzo del 2025 il segretario generale António Guterres ha annunciato il lancio dell'iniziativa UN80, una riforma di ampia portata dell'ONU nel suo 80° anniversario. La riforma mira all'adozione di misure per migliorare l'efficienza del Segretariato, attuare con più efficacia i mandati conferiti all'organizzazione dagli Stati membri e ripensare le strutture del sistema nel suo insieme. I lavori saranno realizzati in più tappe e completati entro la fine del 2025.

I tagli decisi dagli Stati Uniti privano l'azione umanitaria dell'ONU di quasi la metà dei suoi finanziamenti. Questa cospicua riduzione, unita all'annuncio della riduzione dei contributi di altri donatori tradizionali, costringe il sistema umanitario a intraprendere una riforma sistematica di vasta portata. La riforma, annunciata come parte dell'«Humanitarian Reset» – un piano di riforma umanitaria avviato dal coordinatore degli aiuti di emergenza delle Nazioni Unite Tom Fletcher – mira a rendere il sistema più agile ed efficiente.

Valutazione dei temi e dei processi della 79^a Assemblea generale delle Nazioni Unite

I temi citati sopra riflettono le discussioni tenutesi in occasione della 79^a Assemblea generale, che sono state particolarmente importanti dal punto di vista della Svizzera. I negoziati multilaterali all'interno dell'ONU sono condotti da tutti i 193 Stati membri. Quando non è possibile raggiungere un consenso, le decisioni vengono prese a maggioranza. La Svizzera sostiene un multilateralismo mirato ed efficace che pone l'accento sulla sussidiarietà. Grazie al lavoro svolto in seno all'AG-ONU, al recente seggio nel Consiglio di sicurezza e alla presidenza del CDU, la Svizzera si è creata un profilo di costruttrice di ponti, sostenendo un ordine mondiale basato sul diritto internazionale e sui diritti umani. In questo periodo di instabilità geopolitica è necessario ribadire l'importanza del sistema multilaterale ed evitare di allontanarsi dagli standard precedentemente concordati.

Basi della posizione della Svizzera

Il Consiglio federale ha ripetutamente espresso il proprio sostegno a un multilateralismo fondato sui seguenti principi: ordine basato sul diritto internazionale, coerenza, sussidiarietà, efficacia ed efficienza e orientamento al futuro. Questi principi sono validi in molti settori: commercio mondiale, lotta alla povertà e alle pandemie, diritti umani, ambiente, governance digitale e promozione della pace.

La posizione delle delegazioni svizzere in seno all'AG-ONU si basa sulla Strategia di politica estera 2024–2027, sulla Strategia di politica economica esterna, sulla Strategia di cooperazione internazionale 2021–2024, sul rapporto sulla politica di sicurezza, sulla Strategia di politica estera digitale 2021–2024, sulla Strategia di controllo degli armamenti e di disarmo 2022–2025, sulle Linee guida sui diritti umani 2021–2024 e su tutte le altre strategie pertinenti del Consiglio federale.
